Any such extension will be granted subject to a Satisfactory Progress Report and the recommendation of the Departmental (CU) Planning Committee. Alternatively, you must return and join your duties at the university by 15-07-2027. You should also obtain prior permission from the University for any change in course/field of study or institution, along with supporting documents.
