The University of Chittagong or the Govt. of Bangladesh will have no financial responsibilities for your proposed study in Hong Kong.

In this regard, you are requested to apply for extension of Study Leave, along with the consent of the Surety Holders who signed the Surety Bond, at least 03 (three) months before the expiry of the leave. Any such extension will be granted subject to a Satisfactory Progress Report from your Course Supervisor and the recommendation of the Departmental (CU) Planning Committee. Alternatively, you must return and join your duties at the university by 23-08-2027. You should also obtain prior permission from the University for any change in course/field of study or institution, along with supporting documents.
